### Pay Equity: Understanding and Implementing the New Oregon Equal Pay Act

Oregon recently joined the wave of states that have passed pay equity laws aimed at closing the persistent wage gap between men and women. But how does the “pay gap” differ from “pay equity,” and what do these new laws mean for employers seeking to proactively monitor both pay and the practices that influence pay? This CLE seminar will provide an overview of recent legislative and litigation developments – including the changes to Oregon law set to take effect January 1, 2019 – and invite attendees to discuss the challenges of putting pay equity into practice in different companies and workforces.
